10. Neighbourhood Plan Regulation 16 Consultation update

- The consultation run by Ashford Borough Council has closed.
- Some residents experienced difficulty submitting comments, but the Parish Council were able to ensure responses reached Ashford Borough Council.
- Ashford Borough Council requested an extension for their comments until the end of November due to a cancelled meeting and pressures caused by Stour Catchment Area work. The Parish Council advised that it could not directly give permission for a consultation not run by the Parish Council, but understood the circumstances leading to the delay.
- As a result of the Stour Valley water quality issue notified by Natural England, reconsideration needs to be given to whether an environmental assessment is

needed. A response is currently expected by the end of November The independent inspector of the Neighbourhood Plan will need to see this.

• ABC are approaching the independent examiner recommended by Tony Fullwood.

11. Newsletter distribution update

Delivery has been provisionally booked for the week beginning 30 November. It will be added to the website at the time of delivery. Cllr Hall offered to hand deliver to those properties on Lenacre Street falling outside the delivery area.
