$30 / 24$. Resolved: to award a grant of $£ 500$ to Towers Tiny Tots (registered charity number 1149802) to go towards supporting community learning resource bags and food bank.

The Clerk reported that further to queries regarding the responsibilities of the Parish Council as Custodian Trustee for Sandyacres, independent legal advice had been taken to supplement previous enquiries made with Ashford Borough Council and generalised legal advice issued by National Association of Local Councils on custodian trusteeship. A sector specific solicitor in Parish \& Town Council law had reviewed the documentation.

It was advised that the Parish Council holds the legal title to the property comprised in the lease from Ashford Borough Council as corporate Custodian Trustee. As such it has no administrative function in the Charity. The arrangement with the Trustees arises because the Charity is not incorporated and is unable to into transactions such as a lease other than through trustees.

Further queries were raised by Councillors at the meeting, and further local information about the Sandyacres Trust will be sought from trustees.

ii. Attendance at Ashford Borough Council Planning Committee on 13 March 2024 regarding application 21/02146/AS (Eureka Park outline application) was noted, the application was permitted. Councillor Titmuss attended and spoke on behalf of the Parish Council. Detailed advice had been sought from Tony Fullwood, Planning Consultant and he had negotiated additional planning conditions with the Officer in order that the application complied fully with the Boughton Aluph \& Eastwell Parishes Neighbourhood Plan.
