3. Minutes of Previous Meeting

4. Matters arising from the last minutes

- Ashford Borough Council were able to expedite planning permission to fell the tree on green (as advised for safety reasons). It has now been felled, with logs left on site for residents. The siting and species of replacement tree to be notified to ABC after consultation with the cricket club to ensure new tree doesn't obstruct service pipes to new facility.
- The Clerk wrote to Connells regarding attachment of lettings signs to street signs. The request that they do not do this received no acknowledgement.

7. Financial Regulations (updated)

7.1. The updated Financial Regulations are to be examined by the finance committee before bringing to full council.

8. Updates received

8.1. Holes in village green

The cricket club has now been provided with a method statement detailing procedures for dealing with the holes. The ground has to dry out before work can be carried out.

8.2. St Mary's Eastwell, Friends of Friendless Churches

Friends of Friendless Churches have commissioned a tree survey of the site and are in the process of appointing a new architect following the retirement of the previous architect. Once this is done the repairs to church and plans for new fence can be made. A new noticeboard has been commissioned (by FoFC).

8.3. Kempes Corner Flooding, Kent County Council

The Parish Council had reported flooding issues immediately before Christmas and KCC investigated on Christmas Eve. Kent County Council has advised that not all of the remedial work planned was carried out last year. Due to communication issues between KCC and the private contractors this was not realised until after the heavy rain at the end of December. Emergency unblocking has been carried out with rescheduling of works planned to complete the task.

8.4. KALC area committee feedback

- Sergeant Jason Atkinson Kent Police advised that some Parish Councils and Communities are adding bleed kits next to Defibrillators. The cost is approximately £70.
- There was a CCTV presentation from the Ashford Borough Council Head of CCTV Monitoring Centre.
- The KCC Gypsy and Traveller provision consultation is out and PC's should comment where required.

9. Project updates

9.1. KCC Highways Parish Improvement Plan

Cllr Coles reported that a working group meeting was held on 16th January where updated guidelines from KCC were circulated, work will be limited to one scheme each year, which emphasises the long-term nature of the plans. Progress so far includes the extraction of existing crash and incident data for the Parish, identification of further possible data and evidence that may exist and making links with neighbouring Parish Councils to share knowledge. There was discussion regarding the extent to which charging by KCC, in the form of consultancy, as part of a project was desirable. Cllr Phillips to draft letter to County Councillor

9.2. Village Gateways Project (KCC Highways)

The Clerk reported on a meeting with the new officer responsible at Highways, the officer reviewed all the different versions of the scheme requested by the Parish Council. As per the decision in September 2019 it was requested that revised costings for exchanging grey poles for white be provided as soon as possible, ideally before 10th February meeting. It was advised that this would be dependent on external contractor quote being received as white poles are not a standard item.

The KCC officer was very helpful with regard to detailed questions regarding the Parish Improvement Plan, particularly traffic survey information.

9.3. Cricket Pavillion update (Cricket Club) None received to date.

10. Vote on resolution to accept NP

The Parish Council was advised that the reg 15 plan has been submitted to Ashford Borough Council for screening. This process looks at the plan in terms of heritage and environment (involving Environment Agency, Natural England and Historic England).

Resolved: that the Parish Council recommends the submission of the Regulation 15 Neighbourhood Plan to Ashford Borough Council for Independent Examination as soon as possible after screening has been concluded. **Proposed Clir Bunker, Seconded Clir Hall**
