Demolition of existing conservatory and replacement rear single storey extension

Sand pit to the south of 200 and east of 198, Sandyhurst Lane, Boughton Aluph, Kent Outline planning application with details of access for developer-led custom-build residential development of up to 9 dwellings, open space and landscaping, wildlife habitat reserve, new access to Sandyhurst Lane, parking, engineering (including ground modelling) works and infrastructure, with appearance, landscaping, layout and scale reserved for future determination.

Apple Tree Cottage, Wye Road, Boughton Aluph, Ashford, Kent, TN25 4HY Fell tree due to interfering with cables and the highway, also showing signs of being deceased.

Lees Cottage, The Green, Boughton Aluph, Ashford, Kent, TN25 4HX T1: Yew (Taxus baccata) Reduce in height providing a maximum of 1 meter clearance from cables and trim sides using hedge cutters to provide a tight managed framework. S1: Photinia 'Red Robin' Large shrub encroaching on neighbouring property and effecting light levels, reduce from 5.5 Meters to a final height of 4.5 Meters and trim sides
