An enquiry has been received from a resident regarding road safety measures planned for the Sandyhurst Lane 30mph section, and how improvements might be made to the 40mph zone, which includes the Boughton Aluph & Eastwell section. Clerk is corresponding with the resident, and will provide details of the similar plans proposed for the 40mph zone of Sandyhurst Lane included in the Highways Improvement Plan.
