Outline planning application with details of access for developer-led custom-build residential development of up to 9 dwellings, open space and landscaping, wildlife habitat reserve, new access to Sandyhurst Lane, parking, engineering (including ground modelling) works and infrastructure, with appearance, landscaping, layout and scale reserved for future determination.

T1: Yew (Taxus baccata) Reduce in height providing a maximum of 1 meter clearance from cables and trim sides using hedge cutters to provide a tight managed framework. S1: Photinia 'Red Robin' Large shrub encroaching on neighbouring property and effecting light levels, reduce from 5.5 Meters to a final height of 4.5 Meters and trim sides **NO OBJECTION**

ii.Eureka Park Correspondence

A Scoping report was submitted to Ashford Borough Council by developers (ABC have to assess environmental report needed). There has been considerable local concern regarding the proposals, particularly the potential change to previous agreed land allocation.

The Parish Council had received information from ABC on progress.

The planning agent invited the Parish Council to meet. Clarification was sought and received from Ashford Borough Council that such a meeting would be permissible. Advice on planning was sought from Tony Fullwood and shared with Councillors.

Councillors discussed whether to meet the planning agents. It was decided not to meet them at the current time.

It was reported that a formal complaint had been received in writing. It will be responded to in writing within one calendar month.

10. Information items

Jane Hart followed up her email and asked for newsletter ideas. In response to concerns about the safety of hand delivering newsletters it was suggested that delivery was costed in order to reach those who do not engage with digital services.

The Clerk reported contact with a group interested in setting up a Community Speedwatch scheme for the Lees/A251 area of the Parish. They are currently seeking volunteers and if this is successful will approach the Parish Council with a request to use the equipment and for its support for the scheme.
